GETTING TO THE HOTEL

- Take Terminal Access Rd toward I-75/Airport Exit.
- Merge onto I-75 S toward Naples.
- Take County Hwy-850/Corkscrew Rd, EXIT 123, toward Estero/Miramar Outlets Blvd
- Merge onto Corkscrew Rd/County Hwy-850 toward Estero.
- Turn left onto Via Coconut Pt. Pass through 1 roundabout.
- Turn right onto Plaza del Lago Dr.
- Turn left to stay on Plaza del Lago Dr.
- Turn left onto Via Villagio.
